



RENTAL CONDITIONS AND REGULATIONS

Our facilities

We have a special, non-slip synthetic turf that is safer for ligaments and non-carcinogenic. Do not slide on the surface. We recommend track pants or leggings for comfort, not shorts.

Establishment rules

- Clean running shoes are mandatory on the field.
- food or drink is permitted on the field (except water).
- It's strictly forbidden to smoke inside or in front of the entrance.
- Please respect the booking times and leave the field and party space by end of your reservation.

Conditions of rental

1. Rental space is to be used only for the purposes indicated in the contract. The client agrees that the rental space is satisfactory.
2. The client must obtain written authorisation from The Ministry in advance to modify field set up, or to plug in any electric appliance.
3. The client will treat the facilities and equipment with care and notify The Ministry immediately of any problematic situation.
4. The client must return the rental space to the same condition as the start of rental.
5. Piñatas, silly string, or decorations that make a mess are strictly forbidden.
6. The client will not hold The Ministry, its directors or staff liable, and will indemnify The Ministry, its directors and staff from any damage or loss to the client or property or premises, or their guests, including expenses of any kind arising from any actions, claims, or prosecutions. Any insurance is the responsibility of the client and its individual members / guests.



7. The client cannot sub-let or assign its rights in this rental agreement, in whole or part, without being subject to tacit review.
8. The client agrees to entrust the supervision of children and other users to responsible and competent persons and to see that this surveillance is carried out diligently, actively, and continuously.
9. The Ministry reserves the right to ban or suspend players for non compliance of rules, disruption or inappropriate conduct. The client must refuse access to suspended or banned players.
10. At the end of the reservation, the client must remove all their possessions and accessories, and those of their members / guests, and The Ministry will not be deemed responsible for anything left over.
11. The client agrees to pay the total at the moment of making the booking.
12. It is forbidden to bring into the building any animal, bicycle, or any vehicle other than necessary for the movement or help of people with reduced mobility.
13. Emergency exits must only be used for emergencies.
14. The client will not take any action likely to harm The Ministry, its directors, employees, other clients or neighbourhood.
15. The number of people in the rented space must not exceed the maximum number of people indicated in the permit, otherwise the occupation permit may be cancelled.
16. The client must respect the bylaws of establishment and fire safety standards.
17. The client assumes responsibility for any costs imposed by The Montreal Fire Department as a result of the fire alarm being triggered for no good reason, these costs being up to 3 000\$.
18. No modification of this contract except in writing, duly accepted by The Ministry.



19. The Ministry, through their representatives, may, for a major reason, terminate the contract at any time on simple notice to the client (eg. fire, vandalism, major work, emergencies, etc), the client giving up all recourse against The Ministry.

20. The client may bring in their own food, soft drinks, crockery, utensils, and decorations. The Ministry has a bridge, but no freezer. Please adjust the food you bring in accordingly. We ask that you avoid any food that contains nuts.

Your reservation is complete upon reception of payment and a signed contract. It is impossible to cancel your event past 21 days before your reservation date. If you are unable to fulfill your reservation, The Ministry will try to resell the slot for you. If we can fill the space, we can move your booking to a later date or we will issue a credit for a future booking. If, however, your booking is not resold, it will be available for you at the scheduled time and will be charged to you as agreed.

If you are unable to present yourself for your reservation because of transport, snow, or other, The Ministry is not required to recredit your reservation, as long as the establishment is not closed.
